On the Issue of: Human Rights of The Modern Age: Access to The Internet and Net Neutrality

In the modern world, the line between genuinely protecting the best interests of your people and granting them certain human rights just for the sake of keeping up with 'western ideals' has become blurred. The horrendous simplicity to push the trigger and publish any post, whether true or not, allows any citizen to exploit free speech and freedom of information. With fake post reaching 1500 users within 10 hours¹, citizens are left feeling helpless in front of the mass media, and it's the governments they hold responsible: in most nations, more than 80% of the people claim that they do not trust their government². Therefore, the People's Republic of China believes that the questions that must be asked are: must we protect freedom of information at all costs? When must we, the countries - step in?

The People's Republic of China has been connected to the Internet since 1994. Three years later, China started regulating the Internet as a part of the Golden Shield Project in order to protect its citizens, using advanced E-government methods. The project has two phases (which include the Great Firewall): phase 1 – gathering citizen information, has ended in 2003, and phase 2 – enhancing terminal construction and informatizing public application systems, has ended in 2006. Based on our success, we have managed to build and develop a censoring protection system for our citizens³, one which is suited for our culture and way of life.

During the 2016 US elections, many fake posts were spread by the US in China. We have taken this vicious crime as a sign to increase internet regulation and security⁴. Using our Great Firewall, we have eradicated fake news and created trust in our governance.

Opening Statement Guide for Beginners

The Opening Speech is about 60-90 seconds long (150-220 words), and it is the first speech you give to the committee. It is the best opportunity for you to explain your country policy and the key sub-issues you would like the committee to focus on; and to determine what member states your country wants to work with, so it's important to prepare a speech that conveys this. Use your Position Paper as a guide. A good speech is delivered slowly with strategic pauses.

Opening Speech/Policy Guidelines

- I. Header: top left-hand corner: Committee-Country-Issue
- II. Thank presiding Dias member
- III. Talk about the issue background
- IV. What the problem/s is/are, and why it is a problem
- V. Write your country's view on the issue and how it relates to other member states
- VI. Name the major actions/resolutions of the UN and other relevant organizations
- VII. If you have a small country, look for its allied countries or the members of the blocs/organizations it belongs to (e.g., The League of Arab States or African Union)
- VIII. Write solution/s to the problems. State why it can work and how it will benefit your country and the global community/other related member states

Opening Speech Sample 1

The French Republic is no stranger to the phenomenon of youth extremism that ends in horrific terror attacks. We suffered from severe attacks throughout recent years. Almost 250 people have been murdered and hundreds injured in the last two years by young people who were either recruited by terror organizations or incited by their ideology. 2000 French citizens joined ISIL and Syrian jihadist groups which have their hideous propaganda spread through French media and poison our youth.

The French Republic has declared war on these organizations and their bad influence. In September 2016, France opened the first of 12 planned de-radicalization centers in a small town west of Paris. This de-radicalization program works to rehabilitate individuals who may be early on the path to radicalization.

The French Republic believes that we need to address this problem from its root: hundreds of teenagers are exposed to terrible videos and information on different social media platforms that make them to follow this awful path. We also believe we should put more attention to the second generation of refugees in Europe engaging them in different educational programs, in addition to keeping them in check, since they are at the highest risk of radicalization. France believes this conference is the perfect opportunity to combat this world-wide problem and make the world a safer and better place, clean of vicious ideology.

On the Issue of: Robots versus Immigrants

Honorable chairs and distinguished delegates,

The nations of the world have already understood two things. Firstly, that robots, not immigrants, are the way to promote economic and societal growth. Secondly, that robots should be fairly distributed between the nations of the world. Seeing these, the main questions that we should ask ourselves is when and how should we redistribute robots.

The US believes that now is the best time to act. If we don't act now, expensive machinery and robots will be installed in the existing factories, and it will simply be impossible to incentivize these factories to move elsewhere, and the existing gaps between the developing world and the developed world will be irreversible.
